Telcom Semiconductor, Inc. (TLCM) Pending Merger with Microchip Technology Incorporated (MCHP)

On Tuesday, January 16, 2001, the shareholders of Telcom Semiconductor, Inc. (TLCM) will vote to approve the proposed merger with Microchip Techonogy Incorporated (MCHP). If the merger is approved and consummated, each TLCM share will be converted into the right to receive between 0.43 to 0.56 shares of MCHP with cash in lieu of fractional shares of (MCHP).
