Cabletron Systems (CS) has declared a distribution of Common Stock of Riverstone Network Inc. (RSTN) to CS shareholders of record, July 27, 2001. Distribution will be Friday, August 3, 2001. Ex-distribution is August 6, 2001. The final distribution will be 0.5131 shares of Riverstone Network Inc. per share of Cabletron Systems.

On August 6, Cabletron Systems Inc. (CS) will change its name and symbol to Enterasys Networks Inc. (ETS)
