### Tosco Corporation (TOS) Merger with Phillips Petroleum (P)

On April 11, 2001, the shareholders of Tosco Corporation (TOS) approved the proposed merger with Phillips Petroleum (P). When the merger was effective September 14, 2001. Each TOS share will be converted into the right to receive 80 shares of Phillips Petroleum.

#### **Pending Contract Adjustments**

Pursuant to Options Clearing Corporation (OCC) by-laws, all outstanding Tosco Corporation options will be adjusted as follows:

Any additional TOS series added prior to the merger date will also be adjusted in the manner outlined below.
