## Texaco Inc. (TX) Pending Merger with Chevron Corporation (CHV)

On Tuesday, October 9, the shareholders of Texaco Inc (TX) will vote to approve the proposed merger with Chevron Corporation (CHV). If the merger is approved and consummated, each TX share will be converted into the right to receive 0.77 common shares of ChevronTexaco Corporation (CHV). Chevron Corporation is expected to change name to ChevronTexaco Corporation immediately after the merger.

The merger is anticipated to be effective on October 9, 2001

## **Pending Contract Adjustments**

Pursuant to Options Clearing Corporation (OCC) by-laws, all outstanding Texaco Inc. options will be adjusted as follows:

Adjustment Date: Adjustments effective the day following the merger, anticipated to be October 10, 2001

ISE Underlying Symbol No Change

OPRA Option Symbols: TX Becomes XXE

VXC Becomes OXK LTO Becomes KXE

Multiplier: 100\*(eg., Premium of 1.00 = \$100) New Deliverable/Contract: 77 shares of ChevronTexaco Corp

#### **GTC Order Cancellation:**

Immediately after the ISE close on the effective date of the merger, all resting orders in the TX order book will be cancelled.

### **ADJUSTED EXERCISE PRICES:**

Effective with the opening of business, after the date the merger is consummated, trading in TX series will be on an adjusted basis. The strike price adjustments below are expected based on the current outstanding series. Any additional TX series added prior to the merger date will also be adjusted in the manner outlined below.
