L.M.Ericsson Telephone Company (ERICY/RQC) is offering to the holders of ADS's the right to subscribe to additional ADS's of Ericsson. Each shareholder of record as of August 13, 2002 will receive one ADS right for each ADS held. One right entitles the holder to subscribe for one new ADS at the estimated subscription price of \$0.41 per ADS. The expiration date for the rights is August 27, 2002, unless extended. The guarantee period is expected to be three NASDAQ trading days.

Contract Adjustments:

Pursuant to the by-laws of The Options Clearing Corporation ("OCC"), all Ericsson(L.M.) Telephone options will be adjusted as follows:
