Instinet Group, Inc. (INET) Special Cash Dividend

Ex-Distribution Date: 9/23/2002

Instinet Group, Inc. (INET) has declared a Special Cash dividend of \$1 payable to shareholders of record on September 19, 2002. Distribution date for the special cash dividend will be Thursday, October 3, 2002. Ex-distribution date for the stock split will be Monday, September 23, 2002.

### **Contract Adjustments:**

Pursuant to the by-laws of The Options Clearing Corporation ("OCC"), all Instinet Group, Inc. options will be adjusted as follows:

**Adjustment Date:** Effective with exercises of Monday, September 23, 2002 and thereafter.

ISE Underlying Symbol(s): Unchanged - (INET)
OPRA Option Symbol(s): Unchanged - (UAU)

No. of Contracts:

Strike Prices: Reduced by subtracting the cash dividend from each strike and rounding to the nearest eighth.

**Multiplier:** 100 (e.g., Premium of 1.00 = \$100)

New Deliverable/Contract: Unchanged - 100 Shares of Instinet Group, Inc.

### **GTC Order Cancellation:**

On Friday, September 20, 2002, immediately after the ISE close, all resting orders in the INET order book will be cancelled.

#### **Position and Exercise Limits:**

The ISE Surveillance Department has determined that position and exercise limits following this special cash dividend will remain unchanged.

#### **Adjusted Exercise Prices:**

On Monday, September 23, 2002, the ex-distribution date, trading in INET series will be on an adjusted basis. The strike price adjustments listed below are expected based on the current outstanding series. Any additional UAU series added prior to the ex-date will also be adjusted in the manner outlined below.
