Spin-Off/Merger/ 1 for 5 Reverse Split

Ex-Distribution Date: November 19, 2002

AT&T Corporation (T) has declared a distribution of Comcast Corporation (CMCSA) to AT&T Corporation shareholders of record, November 15, 2002. The Distribution will be November 18, 2002.

**Ex-distribution is November 19, 2002.** The distribution will be approximately 20 shares of AT&T Common stock and approximately 32 shares of Comcast Corporation. A 1 for 5 Reverse split will also be effective.
