3 For 1 Stock Split

Cognizant Technology Solutions Corporation (UPU/CTSH) has declared a 3 For 1 common stock split, with a payable datet of April 1, 2003, to shareholders of record March 19, 2003. The ex-date for the stock split is Wednesday, April 2, 2003.

#### **Contract Adjustments:**

Pursuant to the by-laws of The Options Clearing Corporation ("OCC"), all CTSH options will be adjusted as follows:

Adjustment Date: Effective with exercises of Wednesday, April 2, 2003 and thereafter.

No. of Contracts:

Strike Prices: Reduced by dividing existing strikes by 3 and rounding to the nearest eighth.

**Multiplier:** 100 (e.g., Premium of 1.00 = \$100)

New Deliverable/Contract: Unchanged - 100 Shares of Cognizant Tech Solutions Corp.

#### **GTC Order Cancellation:**

On Tuesday, April 1, 2003, immediately after the ISE close, all resting orders in the CTSH order book will be cancelled.

### **Position and Exercise Limits:**

The ISE Surveillance Department has determined that position and exercise limits following this stock split will be 180,000 contracts through the October 18, 2003 expiration date at which time it will revert to its standard limit of 31,500 contracts.
