**Centex Corporation (CTX)**  
**Stock Distribution**  
**Ex-Distribution Date: 7/1/2003**

Centex Corporation (CTX) has declared a distribution of Common Stock of Cavco Industries, Inc. (CVCO) to CTX shareholders of record, June 12, 2003. Distribution will be Monday, June 30, 2003. Ex-distribution is July 1, 2003. The distribution will be 0.05 shares of Cavco Industries, Inc. per share of Centex Corporation.

**Contract Adjustments:**

Pursuant to the by-laws of The Options Clearing Corporation ("OCC"), all Centex Corporation options will be adjusted as follows:

**GTC Order Cancellation:**

On Monday, June 30, 2003, immediately after the ISE close, all resting orders in the CTX order book will be cancelled.

**Unadjusted New Shares:**

New CTX series with a contract unit of 100 shares will be introduced on Wednesday, July 2, 2003. Strike prices and expiration months will be announced on a separate release.

**Adjusted Exercise Prices:**

On Tuesday, July 1, 2003, the ex-distribution date, trading in CTX series will be on an adjusted basis. The strike price adjustments listed below are expected based on the current outstanding series. Any additional CTX series added prior to the ex-date will also be adjusted in the manner outlined below.
