Legato Systems Inc. (LGTO) Pending Merger with EMC Corporation (EMC)

On Monday, October 20, 2003, the shareholders of Legato Systems, Inc. (LGTO) will vote to approve the proposed merger with EMC Corporation (EMC). If the merger is approved and consummated, each LGTO share will be converted into the right to receive 0.90 EMC Common Shares. The merger is expected to become effective on Monday, October 20,2003.

Pending Contract Adjustments
