Stock Distribution

Ex-Distribution Date: 10/29/2003

On October 28, 2003, shareholders of Palm, Inc. (PALM) approved the distribution of Common Shares of PalmSource (PSRC) to Palm, Inc. (PALM) Common Shareholders. The distribution ratio is .3101473963 shares of PSRC for each PALM Common share. The record date is October 28, 2003; the payable date has yet to be determined. NASDAQ NMS has set Wednesday, October 29, 2003, as the ex-distribution date.

Following the distribution, Palm Inc. will acquire Handspring Inc. (HAND) and will change its name and stock symbol to palmOne Inc. (PLMO).

On Tuesday, October 28, 2003, immediately after the ISE close, all resting orders in the PALM order book will be cancelled.

Unadjusted New Shares:

New PALM series with a contract unit of 100 shares will be introduced on Thursday, October 30, 2003. Strike prices and expiration months will be announced on a separate release.

Adjusted Exercise Prices:

On Wednesday, October 29, 2003, the ex-distribution date, trading in UPY series will be on an adjusted basis. The strike price adjustments listed below are expected based on the current outstanding series. Any additional PALM series added prior to the ex-date will also be adjusted in the manner outlined below.
