## Biogen Inc. (BGEN) Pending Merger with IDEC Pharmaceuticals, Corporation (IDEC)

On Wednesday, November 12, 2003, the shareholders of Biogen Inc. (BGEN) will vote to approve the proposed merger with IDEC Pharmaceuticals, Corporation (IDEC). If the merger is approved and consummated, the combined company will be enamed "BIOGEN IDEC INC" and the trading symbol will become "BIIB". Each existing BGEN Common Share will be converted into the right to receive 1.15 BIIB Common Shares. Cash will be paid in lieu of fractional shares.
