On October 6, 2003, General Motors Corporation (GM/GMH) announced that GM and GMH Shareholders approved transactions that will result in the split-off of Hughes of Hughes Electronics Corporation from GM and the subsequent acquisition of 34% of New Hughes Electronics Corporation ("HS") Common Shares by the News Corporation Limited ("NWS.A"). Each GMH Common Share will be exchanged for approximately 0.82335 New Hughes Electronics Corporation ("HS") Common Shares plus an amount of the News Corporation Limited ("NWS.A") American Depositary Shares ("ADS's"), each representing four Preferred Limited Voting Ordinary Shares, cash, or a combination will be \$2
