**Concord EFS, Inc. (CE) Pending Merger with First Data Corporation (FDC)**

On Thursday, February 26, 2004, the shareholders of Concord EFS, Inc. (CE) will vote to approve the proposed merger with First Data Corporation (FDC). If the merger is approved and consummated, each CE share will be converted into the right to receive 0.365 shares, and cash in lieu of 0.5 Fractional Shares of (FDC).

**Pending Contract Adjustments**

Pursuant to Options Clearing Corporation (OCC) by-laws, all outstanding Concord EFS, Inc. options will be adjusted as follows:
