Centex Corporation (CTX) has declared a 2 For 1 stock split payable to shareholders of record on February 29, 2004. Distribution date for the stock split will be Friday, March 12, 2004. Ex-distribution date for the stock split will be Monday, March 15, 2004.

**Contract Adjustments:**
