**Oxford Health Plans (OHP) Merger with UnitedHealth Group Inc. (UNH)**

On Wednesday, July 7, 2004, the shareholders of Oxford Health Plans (OHP) voted to approve the proposed merger with UnitedHealth Group Inc. (UNH). Pursuant to the merger terms each OHP share will be converted into the right to receive .6357 UNH Common Shares plus \$16.17 cash. Cash will be paid in lieu of Fractional UNH Shares.

**Pending Contract Adjustments**

Pursuant to Options Clearing Corporation (OCC) by-laws, all outstanding Oxford Health Plans options will be adjusted as follows:

**Adjustment Date:** Effective with exercises of Friday, July 30, 2004 and thereafter.  
**ISE Underlying Symbol** **OHP becomes HOY**  
**OPRA Option Symbols:** **OHP Becomes HOY**  
**YQP Becomes YQN**  
**OYW Becomes OVA**

**No. Of Contracts:** No Change  
**Multiplier:** 100\*(eg., Premium of 1.00 = \$100)  
**New Deliverable/Contract:** **1) 63 UNH Common Shares**

**3) \$1,617.00 Cash (\$16.17 x 100)**
