#### The News Corporation Limited ADS (NWS/WLN/VGH) Anticipated Adjustment

On Tuesday, October 26, 2004, Shareholders of The News Corporation Limited ADS (NWS) voted and approved a proposed reorganization whereby The News Corporation Limited ADS will reincorporate within the United States. If the reorganization is approved and consummated, each existing NWS American Depository Share will be converted into the right to receive 2 (NEW) The News Corporation (Delaware) (NWS) Class B Common Shares. The Organization is anticipated to become effective prior to the opening of business on Wednesday, November 3, 2004.

#### Pending Contract Adjustments

Pursuant to Options Clearing Corporation (OCC) by-laws, all outstanding The News Corporation Limited ADS options will be adjusted as follows:

#### Unadjusted New Shares:

New NWS series with a contract unit of 100 shares will be introduced on Thursday, November 4, 2004. Strike prices and expiration months will be announced on a separate release.

#### GTC Order Cancellation:

Immediately after the ISE close on the effective date of the merger, all resting orders in the NWS order book will be cancelled.

#### ADJUSTED EXERCISE PRICES:

Effective with the opening of business, after the date the merger is consummated, trading in NWS series will be on an adjusted basis. The strike price adjustments below are expected based on the current outstanding series. Any additional NWS series added prior to the merger date will also be adjusted in the manner outlined below.
