Ask Jeeves, Inc. (ASKJ) Merger with IAC/InteractiveCorp. (IACI) - EFFECTIV

On Tuesday, July 19, 2005, the shareholders of Ask Jeeves, Inc. (ASKJ) approved the proposed merger with IAC/InteractiveCorp. (IACI). As a result of this, each ASKJ share will be converted into the right to receive 1.2668 IACI Common Shares. Cash will be paid in lieu of Fractional Shares of (IACI).

The merger became effective today, Tuesday, July 19, 2005

Pending Contract Adjustments
