## Toys "R" Us (TOY) - Anticipated Cash Settlement- Update to Effective Dat

On June 23, 2005, Shareholders of Toys "R" Us will vote concerning the proposed merger with Global Toys Acquisitio LLC, an entity owned by an investment group consisting of entities advised by or affiliated with Bain Capital Partners LLC Kohlberg Kravis Roberts & Co., L.P. and Vornado Realty Trust. If the merger is approved and consummated, each existin TOY Common Share will be converted into the right to receive \$26.75 net cash per share

## **Contract Adjustments:**

Pursuant to the by-laws of The Options Clearing Corporation ("OCC"), all Toys "R" Us options will b adjusted as follows:
