**Unocal Corporation (UCL) Merger with Chevron Corporation (CVX) - Effective**

On Wednesday, August 10, 2005, the shareholders of Unocal Corporation (UCL) voted on a proposed merger with Chevron Corporation (CVX).

**The Merger: Aggregate Terms**

The merger was approved and consummated. As a result, UCL Common shares will be converted as follows:

An amount of all outstanding UCL Common shares will be converted into 1.03 CVX Common Shares, (Stock Consideration). Cash will be paid in lieu of fractional CVX Shares.

An amount of all outstanding UCL Common Shares will be converted into \$69.00 Cash, subject to prorations (Cash Consideration).

An amount of all outstanding UCL Common Shares will be converted into 0.618 CVX Common Shares and \$27.60 Cash (Mixed Consideration). Cash will be paid in lieu of fractional CVX Shares. The Mixed Consideration will not be subject to prorations.

**The Merger: Individual Share Elections**

Within the terms of the aggregate merger, individual UCL Shareholders were allowed to:

elect to receive 1.03 Chevron Corporation Common Shares (subject to prorations) for each UCL Common Share (Stock Election), or

elect to receive \$69.00 Cash (subject to prorations) for each UCL Common Share (Cash Election), or

elect to receive 0.618 CVX Common Shares and \$27.60 Cash (Mixed Election), or

register no preference by not making an election (Non-election). Under the terms of the election, shares which are not subject to an effective election will automatically be considered "mixed-electing" shares.

**The Merger Consideration: Prorations**

The UCL all Stock and all cash elections will be subject to prorations as described in the UCL Proxy Statement/CVX Prospectus.

**Contract Adjustments**

Pursuant to Options Clearing Corporation (OCC) by-laws, all outstanding Unocal Corporation options will be adjusted as follows:

**Adjustment Date:** Thursday, August 11, 2005

**ISE Underlying Symbol:** UCL becomes CZL

**ISE Commodity Code:** CZL - 1671

**OPRA Option Symbols:** UCL Becomes CZL  
VCL Becomes ZAF  
WCL Becomes LAE

**Strike Prices:** No Change

**No. Of Contracts:** No Change

**Multiplier:** 100\*(eg., Premium of 1.00 = \$100)

**New Deliverable/Contract:** The deliverable for adjusted Unocal Corporation options will be based on the merger consideration which accrues to non-electing UCL Shareholders

(stated in terms of a current 100-share UCL deliverable).

- 1) 61 Chevron Corporation (CVX) Common Shares
- 2) Cash in lieu of .8 fractional CVX Shares
- 3) \$2.760.00 Cash (\$27.60 x 100)

Effective with the opening of business on Thursday, August 11, 2005, trading in UCL series will be on an adjusted basis. The strike price adjustments below are expected based on the current outstanding series. Any additional UCL series added prior to the merger date will also be adjusted in the manner outlined below.
