Nextel Communications Inc. (NXTL) Merger with Sprint Corporation (FON) - Effectiv

On Wednesday, July 13, 2005, the shareholders of Nextel Communications Inc. (NXTL) voted concerning a proposed merger with Sprint Corporation (FON). The merger was approved and subsequently consummated on August 12, 2005. As a result, each existing NXTL Common Share will be converted into the right to receive 1.28 Series 1 Common Shares of the new combined Company, "Sprint Nextel Corporation"(S), plus cash valued at .02 times the average Sprint Nextel Corporation price as described in the Joint Proxy Statement/Prospectus. The stock and cash considerations are subject to adjustments. Cash will be paid in lieu of fractional shares

Pending Contract Adjustments
