IVAX Corporation (IVX) Pending Merger with Teva Pharmaceutical Industries Limited (TEV/

On Thursday, October 27, 2005, the shareholders of IVAX Corporation (IVX) will vote to approve the proposed merge with Teva Pharmaceutical Industries Limited (TEVA)

Ivax Corporation and Teva Pharmaceutical Industries Ltd. Have announced that the Election deadline will be extended to to business days before the effective date of the merger, which has yet to be determined

The Merger: Aggregate Terms

If The merger is approved and consummated, IVX Common shares will be converted as follows

50% of all outstanding IVX Common shares will converted into .8471 TEVA Common Shares, subject to proration (Stock Consideration). Cash will be paid in lieu of fractional TEVA Shares

50% of all outstanding IVX Common Shares will be converted into \$26.00 Cash, subject to prorations (Cash Consideration

The Merger: Individual Share Elections

Within the terms of the aggregate merger, individual IVX Shareholders may

elect to receive .8471 Teva Pharmaceutical Industries Limited Common Shares (subject to proration) for each IVX Common Shar (Stock Election), or

elect to receive \$26.00 Cash (subject to proration) for each IVX Common Share (Cash Election), o

elect to receive a combination of stock and cash (subject to proration)(Mixed Election), o

register no preference by not making an election (Non-election). Under the terms of the election, shares which are not subject to a effective election will automatically be considered "non-electing" shares

The Merger Consideration: Prorations

The IVX election will be subject to prorations as described in the IVX Proxy Statement/TEVA Prospectu:

Effective Date of the Merger

The merger is expected to become effective in late 2005 or early 2006

Pending Contract Adjustments

Pursuant to Options Clearing Corporation (OCC) by-laws, all outstanding IVAX Corporation options will t adjusted as follows:
