**AT&T Corporation (T) Merger with SBC Communications Inc. (SBC)- EFFECTIVE**

On Thursday, June 30, 2005, the shareholders of AT&T Corporation (T) approved the proposed merger with SBC Communications Inc. (SBC) and a subsidiary of SBC. The merger was consummated on November 18, 2005. As a result, SBC Communications Inc. will change its name to AT&T Corp., and each existing T Common Share will be converted into the right to receive 0.77942 "NEW" AT&T Inc. (SBC) Common Shares. Cash will be paid in lieu of fractional SBC Shares.
