Activision, Inc. (ATVI) 4 for 3 Stock Split Ex-Distribution Date: 3/23/2005

Activision, Inc. (AQV/ATVI) has declared a 4 for 3 stock split payable to shareholders of record on March 7, 2005. Distribution date for the stock split will be Tuesday, March 22, 2005. Ex-distribution date for the stock split will be Wednesday, March 23, 2005.

Contract Adjustments:

Pursuant to the by-laws of The Options Clearing Corporation ("OCC"), all Activision, Inc. options will be adjusted as follows:

Adjustment Date:	Effective with exercises of Wednesday, March 23, 2005 and thereafter.
ISE Underlying Symbol(s):	Unchanged - ATVI
OPRA Option Symbol(s):	AQV/WXT/VEN becomes AHV/WIM/VCD
Size of Contract:	133 shares
Strike Prices:	Reduced by dividing existing strikes by 1.33 and rounding to the nearest eighth.
Multiplier:	133 (e.g., Premium of 1.00 = \$133)
New Deliverable/Contract:	133 Shares of Activision, Inc.

GTC Order Cancellation:

On Tuesday, March 22, 2005, immediately after the ISE close, all resting orders in the ATVI order book will be cancelled.

Position and Exercise Limits:

The ISE Surveillance Department has determined that position and exercise limits following this stock split, and until January 20, 2007 expiration will be any combination of AQV and AHV/WIM/VCD options not to exceed 33,250,000 shares of A[¬] through the January 20, 2007, at which time it will revert to its standard limit of 25,000,000 shares.

Unadjusted New Shares:

New ATVI series with a contract unit of 100 shares will be introduced on Thursday, March 24, 2005. Strike prices and expiration months will be announced on a separate release.

Adjusted Exercise Prices:

On Wednesday, March 23, 2005, the ex-distribution date, trading in ATVI series will be on an adjusted basis. The strike price adjustments listed below are expected based on the current outstanding series. Any additional ATVI series added prior to the ex-date will also be adjusted in the manner outlined below.
