**ADC Telecommunications, Inc. (ADCT)**  
**1 for 7 Reverse Stock Split**  
**Ex-Distribution Date: 5/10/2005**

On April 18, 2005, ADC Telecommunications Inc. (ADCT) announced a 1 For 7 reverse stock split. One ADCT Common share will be converted into the right to receive .14285714 (New) ADC Telecommunications, Inc. (ADCTD) Common Share. The effective date of the reverse split is anticipated to be Tuesday, May 10, 2005.

**Please note that effective Tuesday May 10, 2005, and continuing for a period of twenty days ADC Telecommunications, Inc. will trade under the underlying symbol of ADCTD. After that 20 day period, ADC Telecommunications, Inc. will resume Trading under the ADCT Symbol.**

**Contract Adjustments:**

Pursuant to the by-laws of The Options Clearing Corporation ("OCC"), all Activision, Inc. options will be adjusted as follows:

**Unadjusted New Shares:**

New TLQ series with a contract unit of 100 shares will be introduced on Wednesday, May 11, 2005. Strike prices and expiration months will be announced on a separate release.

On Tuesday, May 10, 2005, the ex-distribution date, trading in YZR series will be on an adjusted basis. The strike price adjustments listed below are expected based on the current outstanding series. Any additional YZR series added prior to the ex-date will also be adjusted in the manner outlined below.
