**Veritas Software Corp. (VRTS) Pending Merger with Symantec Corporation (SYMC)**

On Friday, June 24, 2005, the shareholders of Veritas Software Corp. (VRTS) will vote to approve the proposed merger with Symantec Corporation (SYMC). If the merger is approved and consummated, each VRTS share will be converted into the right to receive 1.1242 SYMC Common shares. cash will be paid in lieu of Fractional SYMC shares

**Pending Contract Adjustments**

Pursuant to Options Clearing Corporation (OCC) by-laws, all outstanding Veritas Software Corp. options will be adjusted as follows:
