Coldwater Creek, Inc. (CWTR) 3 For 2 Stock Split Ex-Distribution Date: 1/17/2006

Coldwater Creek, Inc. (UCJ/CWTR) has declared a 3 For 2 stock split payable to shareholders of record on December 23, 2005. Distribution date for the stock split will be Friday, January 13, 2006. Ex-distribution date for the stock split will be Tuesday, January 17, 2006.

## **Contract Adjustments:**

Pursuant to the by-laws of The Options Clearing Corporation ("OCC"), all Coldwater Creek, Inc. options will be adjusted as follows:

### GTC Order Cancellation:

On Monday, January 16, 2006, immediately after the ISE close, all resting orders in the CWTR order book will be cancelled.

### Position and Exercise Limits:

The ISE Surveillance Department has determined that position and exercise limits following this stock split, and until July 22, 2006 expiration will be any combination of UCJ and CWK options not to exceed 30,000,000 shares of CWTR, through the July 22, 2006, at which time it will revert to its standard limit of 20,000,000 Shares.

## Unadjusted New Shares:

New CWTR series with a contract unit of 100 shares will be introduced on Wednesday, January 18, 2006. Strike prices and expiration months will be announced on a separate release.

#### Adjusted Exercise Prices:

On Tuesday, January 17, 2006, the ex-distribution date, trading in CWTR series will be on an adjusted basis. The strike price adjustments listed below are expected based on the current outstanding series. Any additional CWTR series added prior to the ex-date will also be adjusted in the manner outlined below.
