Ex-Distribution Date: 2/13/2006

On January 31, 2006, Oracle Corporation (ORCL) completed a merger with Siebel Systems, Inc.(SEBL), a component of the Software HOLDRs Trust (SWH). Non electing SEBL Common Shares were converted into the right to receive \$10.66 cash per share. As a result, the cash entitlement of the SEBL Common Share component of the Software HOLDRs Trust (SWH) will be distributed to SWH Shareholders. The distribution ratio is \$85.28 for each 100 share round lot of SWH HOLDRs. The record date is February 15, 2006. The mail date is February 17, 2006. The American Stock Exchange has set February 13, 2006 as the ex-distribution date.

Contract Adjustments:

Pursuant to the by-laws of The Options Clearing Corporation ("OCC"), all Software HOLDRs Trust options will be adjusted as follows:

Please note that previoulsy adjusted STH and SDP contracts both contain deliverables which no longer trade on a national market (MERQ). Mercury Interactive Coporation (MERQ) was delisted from the NASDAQ effective January 4, 2006. Therefore, effective Friday, January 13, 2006, ISE began conducting customer closing transactions only for all outstanding STH and SDP contracts.

GTC Order Cancellation:

On Friday, February 10, 2006, immediately after the ISE close, all resting orders in the SWH order book will be cancelled.

Unadjusted New Shares:

New SWH series with a contract unit of 100 shares will be introduced on Tuesday, February 14, 2006. Strike prices and expiration months will be announced on a separate release.

Adjusted Exercise Prices:

On Monday, February 13, 2006, the ex-distribution date, trading in SWH series will be on an adjusted basis. The strike price adjustments listed below are expected based on the current outstanding series. Any additional SWH series added prior to the ex-date will also be adjusted in the manner outlined below.
