**Scientific-Atlanta, Inc. - Cash Settlement Effective**

On February 2, 2006, the shareholders of Scientific-Atlanta, Inc.(SFA) voted concerning the proposed merger with a subsidiary of Cisco Systems, Inc. The merger was approved and subsequently consummated on February 24, 2006. As a result, each existing SFA Common Share will be converted into the right to receive \$43.00 net cash per share.
