Archipelago Holdings, Inc. (AX) - Anticipated Adjustment due to Proposed Merger with NYSE Group, Inc. (NY)

On Tuesday, December 6, 2005, the shareholders of Archipelago Holdings, Inc. (AX) voted concerning a proposed merger with The New York Stock Exchange, Inc. The merger was approved and, when consummated, each existing AX Common share will be converted into the right to receive one (1) "New" NYSE Group, Inc. (NYX) (Holding Company) Common Share. Cash will be paid in lieu of fractional NYX Shares.

Pending Contract Adjustments

Pursuant to Options Clearing Corporation (OCC) by-laws, all outstanding Archipelago Holdings, Inc. options will be adjusted as follows:
