**Starwood Hotels & Resorts Worldwide, Inc. (HOT) Anticipated Adjustmen**

On Wednesday, April 5, 2006, the shareholders of Starwood Hotels & Resorts Worldwide, Inc. (HOT) voted concerning the proposed merger with Host Marriott Corporation (HMT). Starwood Hotels & Resorts Worldwide, Inc. Paired Shares (HOT) currently consist of one Starwood Hotels & Resorts Worldwide, Inc. Common Share and one REIT Class B Share. If the Merger is approved, each REIT Class B Share will be de-paired after the close of business on April 7, 2006. Upon consummation of the merger, each existing REIT Class B Share will be converted into the right to receive 0.6122 HO Common Shares plus \$0.503 Cash. Cash will be paid in lieu of fractional HMT Shares

**Pending Contract Adjustments**
