### TOP Tankers, Inc. (TOPT) Special Cash Dividend Ex-Distribution Date: 4/12/2006

TOP Tankers, Inc. (QLT/TOPT) has declared a Special Cash dividend of \$2.50 payable to shareholders of record on April 17, 2006. Distribution date for the special cash dividend will be Tuesday, April 25, 2006. Ex-distribution date for the stock split will be Wednesday, April 12, 2006.

### **Contract Adjustments:**

Pursuant to the by-laws of The Options Clearing Corporation ("OCC"), all TOP Tankers, Inc. options will be adjusted as follows:

Strike Prices:	Reduced by subtracting the cash dividend from each strike and rounding to the nearest eighth.

New Deliverable/Contract:	Unchanged - 100 Shares of TOP Tankers, Inc.

#### **GTC Order Cancellation:**

On Tuesday, April 11, 2006, immediately after the ISE close, all resting orders in the TOPT order book will be cancelled.

### **Position and Exercise Limits:**

The ISE Surveillance Department has determined that position and exercise limits following this special cash dividend will remain unchanged.

On Wednesday, April 12, 2006, the ex-distribution date, trading in TOPT series will be on an adjusted basis.
