#### Special Cash Dividend

Ex-Distribution Date: 4/25/2006

Cablevision Systems Corp. (CVC) has declared a Special Cash dividend of \$10.00 payable to shareholders of record on April 18, 2006. Distribution date for the special cash dividend will be Monday, April 24, 2006. Ex-distribution date for the stock split will be Tuesday, April 25, 2006.

#### Contract Adjustments:

Pursuant to the by-laws of The Options Clearing Corporation ("OCC"), all Cablevision Systems Corp. options will be adjusted as follows:

- Adjustment Date:** Effective with exercises of Tuesday, April 25, 2006 and thereafter.
- ISE Underlying Symbol(s):** CVC Becomes CZS
- ISE Commodity Code:** CZS -5251
- OPRA Option Symbol(s):** CVC/VJK/WJD Beome CZS/VTP/WRD
- No. of Contracts:** 1
- Strike Prices:** Reduced by subtracting the cash dividend from each strike and rounding to the nearest eighth.
- Multiplier:** 100 (e.g., Premium of 1.00 = \$100)
- New Deliverable/Contract:** 1) 100 Cablevision Systems Corp. (CVC) Common Shares  
2) \$1,000.00 Cash (10.00 X 100)

#### GTC Order Cancellation:

On Monday, April 24, 2006, immediately after the ISE close, all resting orders in the CVC order book will be cancelled.

#### Position and Exercise Limits:

The ISE Surveillance Department has determined that position and exercise limits following this special cash dividend will remain unchanged.

#### Adjusted Exercise Prices:

On Tuesday, April 25, 2006, the ex-distribution date, trading in CVC series will be on an adjusted basis. The strike price adjustments listed below are expected based on the current outstanding series. Any additional CVC series added prior to the ex-date will also be adjusted in the manner outlined below.
