3 For 1 Stock Split

Ex-Distribution Date: 5/31/2006

Talisman Energy, Inc. (TLM) has declared a 3 For 1 stock split payable to shareholders of record on May 25, 2006. Distribution date for the stock split will be Tuesday, May 30, 2006. Ex-distribution date for the stock split will be Wednesday, May 31, 2006.

Contract Adjustments:

Pursuant to the by-laws of The Options Clearing Corporation ("OCC"), all Talisman Energy, Inc. options will be adjusted as follows:

Adjustment Date: Effective with exercises of Wednesday, May 31, 2006 and thereafter.

ISE Underlying Symbol(s): Unchanged - TLM OPRA Option Symbol(s): Unchanged - (TLM)

No. of Contracts:

Strike Prices: Reduced by dividing existing strikes by 3 and rounding to the nearest eighth.

Multiplier: 100 (e.g., Premium of 1.00 = \$100)

New Deliverable/Contract: Unchanged - 100 Shares of Talisman Energy, Inc.

GTC Order Cancellation:

On Tuesday, May 30, 2006, immediately after the ISE close, all resting orders in the TLM order book will be cancelled.

Position and Exercise Limits:

The ISE Surveillance Department has determined that position and exercise limits following this stock split will be 75,000,000 Shares through the January 20, 2007 expiration date at which time it will revert to its standard limit of 25,000,000 Shares.

Adjusted Exercise Prices:

Effective with the opening of business, on Wednesday, May 31 2006, trading in TLM series will be on an adjusted basis. The strike price adjustments below are expected based on the current outstanding series. Any additional TLM series added prior to the split date will also be adjusted in the manner outlined below.
